: Lead line (must be lead by a person 18 or over and child must be over 2); Small Fry 8 yrs old and under; Junior 9-12 yrs old; Intermediate 13-17 yrs old; Senior 18-29 yrs old; Super Senior 30- 49 yrs old and super Pro over 50.

Please familiarize yourself with the riding rules of WVSC and AQHA and APH. Shows are based on a combination of AQHA & WVSC Rules.

Arena Manager's decision is final in all shows.

Ties will be determined by sling shot. A five (5) second penalty will be added to rider's time for knocking over cone, barrel, pole, etc. Proper Dress & Tack Required.

Please do not leave your horse(s) unattended and **clean up after yourself and your horse!**

If you are participating for highpoint, you must be in at least three (3) highpoint classes.
